# MINUTE 444.13 PROPOSAL TO APPOINT POSTGRADUATE MAINSUPERVISOR FROM OTHER KULLIYYAHS OR UNIVERSITIES, CENTRE FOR POSTGRADUATE STUDIES- S.P. NO. D1541/444/2018- S.P. NO. D1541/444/2018

#### 1.0 The Senate was presented with the following:

A proposal for the endorsement of the recommendation to appoint a main-supervisor from other Kulliyyahs or Universities by the Deans' Council in its meeting No. 3/2018 held on 2<sup>nd</sup> March 2018.

### 1.1 The proposals are as follows:

i. Appointment of a main-supervisor from another Kulliyyah (Kyh)

(Student from Kyh-A, taking programme kyh-A, but Supervisor from Kyh-B)

- a. Recommendation to appoint a main-supervisor from another Kulliyyah can be made by the main Kulliyyah (where the PG student is attached) or by the PG student and should be accompanied by a written consent from the proposed main-supervisor.
- b. The appointment is to be endorsed by the KPGC of the main Kulliyyah where the student is attached. Relevant documents such as potential supervisor's CV and experiences should be taken into consideration to justify the appointment.
- c. This proposal is also applicable between two departments in the same Kulliyyah.
- ii. A staff member from a Kulliyyah supervising its own student under PG programmes offered by other Kulliyyah.

(Student from Kyh-A, Supervisor from kyh-A, but Programme from Kyh-B

a. Postgraduate programmes that are common to more than one Kulliyyah are to be identified and listed

under both (or more) involved Kulliyyahs upon getting Senate endorsement. Relevant approvals should be obtained from professional bodies, if any, before getting Senate endorsement.

- b. Once approved by Senate, the common programmes will be cross listed under both kulliyyahs. As such, each Kulliyyah can register PG students directly into the programme under its own Kulliyyah.
- c. The approved common programmes will be listed under both Kulliyyahs when potential students apply through the 'e-Admission online application'.

## iii. Appointment of supervisor from another University or institution (e.g. research institutes)

- a. A Kulliyyah owning a programme but not having the expertise (within the Kulliyyah or university) to supervise a particular thesis title may appoint staff from another university or institution (local or International) as the main-supervisor.
- b. The Chairman of the supervisory committee, and at least one co-supervisor should be from IIUM.
- c. Such appointments should be approved by the Kulliyyah Postgraduate Committee (KPGC) and endorsed by the Senate.

Details of the proposal are as appended in the 444<sup>th</sup> Senate e-Meeting system.

#### 2.0 Senate decision

2.1 The Senate concurred with and endorsed the recommendation to appoint main-supervisor from other Kulliyyahs by the Deans' Council in its meeting No. 3/2018 held on 2<sup>nd</sup> March 2018 except for proposal iii.
